### **Recommendation**

StanCOG staff recommends, by **MOTION**, to formally withdraw Amendment #11 to the 2009 Interim FTIP.

Amendment #11 was adopted by the StanCOG Policy Board on September 9, 2009. This recommendation by StanCOG staff to withdraw Amendment #11 is being made due to the Policy Board's adoption of StanCOG's new programming and amendment procedures. The item(s) which were adopted in Amendment #11 shall be incorporated into Amendment #13 to the 2009 Interim FTIP. This item was not presented to the StanCOG Advisory Committee structure as it was only suggested to StanCOG staff by FHWA on October 29, 2009.

A draft of Amendment #13 will be presented for consideration to each of StanCOG's Advisory Committees and then presented to the Policy Board for adoption on December 9, 2009. The Notification for Public Hearing for Amendment #13 began on November 1, 2009.
