

**NOTICE OF PUBLIC HEARING ON THE  
DRAFT 2009 FEDERAL TRANSPORTATION IMPROVEMENT PROGRAM AND  
CORRESPONDING AIR QUALITY CONFORMITY ANALYSIS  
AND  
THE DRAFT 2009 FEDERAL INTERIM TRANSPORTATION IMPROVEMENT  
PROGRAM**

NOTICE IS HEREBY GIVEN that the Stanislaus Council of Governments (StanCOG) will hold a public hearing on June 11, 2008, at 6:00 p.m. in the Council Chambers, 1010 Tenth Street, Modesto, California regarding the Draft 2009 Federal Transportation Improvement Program (FTIP) and Corresponding Air Quality Conformity Analysis and the Federal Draft 2009 Interim Transportation Improvement Program (Interim TIP). The purpose of the hearing is to receive public comments.

- The FTIP is a listing of capital improvement and operational expenditures utilizing federal and state monies for transportation projects in Stanislaus County during the next four years.
- The Air Quality Conformity Analysis contains the documentation to support a finding that the 2009 FTIP and 2007 RTP meet air quality conformity requirements for carbon monoxide, ozone and particulate matter.
- The Interim FTIP has been prepared concurrently with the FTIP and contains only the transportation projects that may proceed if the conformity analysis cannot be adopted.
- Updated year of expenditure tables for the StanCOG 2007 RTP are also being provided; however, they do not require an RTP amendment and do not affect the adopted 2007 StanCOG RTP Environmental Impact Report.

Translation services are also available (with 3-working-day advance notice) to participants speaking any language with available professional translation services.

A concurrent 30-day public review and comment period will commence on May 19, 2008, and conclude on June 17, 2008. The draft documents are available for review at the StanCOG office, located at 900 H Street, Suite D, Modesto, CA, 95354 and on our website at [www.stancog.org](http://www.stancog.org).

Public comments are welcomed at the hearing, or may be submitted in writing by 5:00 PM, June 17<sup>th</sup>, 2008 to Carlos Yamzon at the address below.

After considering the comments, the documents will be considered for adoption, by resolution, by the StanCOG Policy Board at a regularly scheduled meeting to be held on July 9<sup>th</sup>, 2008 at 6:00 p.m. in the Council Chambers, 1010 Tenth Street, Modesto, California. The documents will then be submitted to state and federal agencies for approval.
